S Y N O P S I S

This study is concerned with the identification of urban land problems and some recommendations specially towards a strategy for urban land development in relation to land use in the Western Province of Sri Lanka. The dissertation is in 4 parts comprising of 8 Chapters.


Part 1 deals with the existing setting of the Western Province with a view to identifying urban land problems and examine policies relating to urban land use. Chapter 1 examines the General Background of the study region with regard to its location, physical characteristics, the history of its development, demographic characteristics and Land Use. Chapter 2 examines the General Background of the Case Study Areas. Chapter 3 reviews Policies, Plans and Programmes in the Study Area especially pertaining to Urban Land Use.

Part 2 reviews the Theoretical framework of Urban Land Use in Chapter 4. The patterns of Urban Land Use, Goals and objectives of a Land-Use Policy, strategy options in Land-Use planning are dealt with, to relate to the Western Province situation in Part 3.

Part 3 comprises the analytical section. Chapter 5 discusses the nature and magnitude of problems, potentials and constraints related to Urban Land-Use in the Study Area arising out of the existing pattern. Chapter 6 analyses the Impacts and Implications of Policies on urban land problems and the attainment of Goals and Objectives. Chapter 7 reviews urban land problems in other countries and Policies adopted and attempted remedies, taking a few cities as examples, all of which leads to conclusions and strategy proposals for the study area in Part IV. Chapter 8 in part IV contains conclusions of the study and strategy proposals.
